## **Purpose of the Role:**

This fixed-term, part-time role is part of the University of Nottingham's Rights Lab Beacon of Excellence, which is delivering research to help end contemporary slavery. The role-holder will work across multiple Rights Lab teams, collaborating with Nottingham staff members on research, impact and grant submissions. In order to maximize the possibilities for collaborative and team-based work, he/she should bring at least two of the following areas of expertise: contemporary slaveholders and their motivations; the narratives of contemporary slavery survivors; the use of technology by antislavery movements; contemporary slavery and debt bondage in India. The role-holder should already have a strong portfolio of publications for REF2021, for submission with the School of Sociology and Social Policy. He/she should have a track record of securing research income. The role will not require any teaching or administrative responsibilities and is available on a part-time, fixed-term basis from January 2018 until July 2021.

7	To provide guidance and mentorship to early-career staff at the University of Nottinghan where appropriate in own area of expertise.	
8	To plan and manage own research activity and resolve problems, if required, in meeting own/team research objectives and deadlines in collaboration with others.
