Job Title: Dissection Room Technician

## Purpose of the New Role:

The purpose of the role is to provide timely and high quality technical and administrative support to the Anatomy Teaching Suite in the School of Life Sciences, in support of activities undertaken within the licensed premises in line with the requirements of the Human Tissue Act (2004). The role holder will be responsible for the general upkeep of the area as well as the use and maintenance of equipment. The role holder will also support the administration of the running of courses within the facility.

Provide support to senior technical staff in the extraction, storage and maintenance and preparation of body parts and other teaching materials for use by teaching staff in laboratory practicals, which may involve the use of a band saw and other tools. Accepting and transporting cadavers in to the DR in the absence of the DR manager as required.	30%
2.	To maintain clean equipment and a high standard of housekeeping. Perform basic calibrations and maintenance of equipment and glassware.	15%
3.	To monitor and maintain stocks levels/stores of basic equipment and supplies ensuring that equipment, consumables and work areas are ready to use as and when required.	15%

## **Additional Information**

The Faculty of Medicine and Health Sciences currently has around 5300 undergraduate students and 900 postgraduate taught students registered on courses within the four Schools. The Anatomy Teaching Suite primarily facilitates teaching to students registered on undergraduate medicine and physiotherapy courses, as well as those registered on postgraduate medicine and nursing courses. Alongside this, CPD activities are facilitated for staff working for Nottingham University Hospitals NHS Trust who work in the Professions Allied to Medicine, and provide surgical skills training for local, national and international delegates using cadaveric material.

This role is instrumental in underpinning the on-going success of the cadaveric laboratory, delivering and ensuring the upkeep and maintenance of the cadaveric specimens held within the licensed area, as well as providing technical support to external stakeholders and all users of the facility. This role also encompasses administrative functions to support the successful bequest programme operated by the University of Nottingham, ensuring on-going compliance with the Human Tissue Act (2004) as well as the Human Tissue Authority Codes of Practice.

Because of the nature of the work for which you are applying, this post is exempted from the provisions of Section 4 (2) of the Rehabilitation of Offenders Act 1974 by virtue of the Rehabilitation of Offenders Act 1974 (Exceptions) Order 1975.
