## Purpose of role

The purpose of this role is to provide high quality teaching in Global History. You will have specialist expertise in the colonial history of South Asia, and will engage in the planning, designing and teaching of the modules: HIST2049 'Rule and Resistance in Colonial India' and HIST3109 Slavery, Caste & Capitalism'. You will also convene an MA module on Global History and may contribute to Year 1 seminar teaching and dissertation supervision.

You will have personal tutoring responsibilities and undertake such administrative tasks as agreed with the Head of Department.
